

## 50+ ways to integrate biodiversity and nature-based solutions – a UN system commitment to collective action for people and planet

The following table provides an illustrative list of practical interventions the UN system can pursue jointly as part of the **Common Approach to Integrating Biodiversity and Nature-based Solutions for Sustainable Development into United Nations Policy and Programme Planning and Delivery (CEB/2021/1/Add.1)**. The table is structured according to the 3 impact areas and 15 medium-term objectives of the Common Approach. The first column presents a non-exhaustive list of actions that the UN system can pursue at all levels to implement the Common Approach. Column two expands on potential examples to operationalize each action, while columns three and four identify which UN entity could be involved and what already-existing resources the actions could build on. Finally, a link to the Sustainable Development Goals (SDGs) is established in column five.
