Subject: Revised rates for short-term conference interpreters, effective 1 July 2021

and 1 January 2022

- 1. In accordance with the 2019 CEB-AIIC Agreement, I am pleased to share the daily net rates for short-term conference interpreters with effect 1 January 2022.
- 2. I am further pleased to share that the CEB and the AIIC have (retro-actively) agreed on the rates with effect from 1 July 2021, which are the same as the rates that took effect on 1 January 2021, which have been applied pending the agreement between the CEB and AIIC.

- 3. Please note that the rates will remain in effect until 30 June 2022 and have been calculated in compliance with the 'non-regression clause' set out in paragraphs 16 18 of Annex E to the 2019 CEB-AIIC Agreement, and as such, the rates to take effect on 1 January 2022 are the highest between those in effect as of 1 January 2020 and those re-calculated as of 1 January 2022.
- 4. Furthermore, the rates have been calculated in United States dollars and were then converted into local currencies as per the methodological parameters of the 2019 CEB-AIIC Agreement, i.e. the 12-month rolling average of the United Nations operational rates of exchange.
- 5. With respect to the World rates, the 2019 CEB-AIIC Agreement regulates that these are calculated in United States dollars, which is also the currency of payment. However, under separate agreements within member organizations, payments may be made in the currency of the country of the short-term conference interpreter's domicile or in a third currency, on the condition that this does not represent an additional cost to the member organization and is operationally feasible. In such instances, the rate of exchange to be applied shall be the monthly United Nations operational rate of exchange in force on the date that the payment is made.
- 6. Finally, please note that further to the ICSC Comprehensive Compensation Review for UN System staff members and the resultant changes to the salary scale for staff members in the Professional and higher categories, an adjustment factor of 1 % has been added to the P-4, Step 6 salary in the unified salary scale applicable on 1 January 2022.
